

COVID-19: A Business Guide to Who's Who in Government Response


The Australian Government's response to Covid-19 involves a combination of new entities and old entities to act as decision makers, policy formulators, policy deliverers, co-ordinators and support entities.

The key entity is the National Cabinet, comprised of the Prime Minister and all the Premiers and Chief Ministers. In the Australian Government, the two key Cabinet sub-Committees are the **National Security Committee Covid-19 Task Force**, and the **Expenditure Review Committee**.

Government Departments and Agencies are playing critical roles, and many have established internal Task Forces and Units dedicated to the Covid-19 issue.

This Brief describes the key entities involved, particularly as they relate to business.

KEY ENTITIES

National Cabinet

Summary: The National Cabinet is the pre-eminent decision making body in Australia regarding the Covid-19 crisis. Decisions are not binding on jurisdictions, but the aim is, where possible, consensus on key matters.

Cabinet Sub-Committees

The Cabinet (23 Ministers) is the main decision-making entity in the Australian Government, but there are two main Cabinet Sub-Committees dealing with Covid-19 – the National Security Committee Covid-19 Task Force, and the Expenditure Review Committee.

Australian Health Protection Principals Committee (AHPPC)

Summary: This is the key co-ordinating mechanism in the Department of Health during medical emergencies (as it is for this one). Around 150 people staffing it, including epidemiologists, doctors, pathologists, crisis managers, Home Affairs officials and border health and biosecurity agency officials. It also runs communications, public information and public awareness. Running 24/7.

Summary: Newly established (25 March) to co-ordinate advice to the Government on mitigating the economic and social effects of Covid-19. The National Coordination Mechanism (based in the Department of Home Affairs), which coordinates the cross jurisdictional response to non-health aspects of the pandemic, will report to the Commission, as will the Coronavirus Business Liaison Unit (based in the Treasury Department).
