Measuring What Matters – second consultation process

Introduction

We represent the Community Housing Industry Association (CHIA) and National Shelter and are writing to you about Stage Two of the consultation for Measuring What Matters. We welcome the opportunity to further engage with the process, particularly being able to bring forward the views of the Australian housing and homelessness sector.

CHIA is the peak body representing not for profit community housing organisations (CHOs) across Australia. Our 150+ members manage a \$40 billion-plus portfolio of more than 115,000 homes, housing people on low and moderate incomes who find it hard to access affordable and appropriate tenancies in the private market.

National Shelter is a non-government peak body that aims to improve housing access, affordability, appropriateness, safety and security for people living on low incomes. Since 1975, National Shelter has worked towards this goal by influencing government policy and action, and by raising public awareness about housing issues.

Both National Shelter and CHIA each provided a submission to Stage One of the Measuring What Matters consultation¹.

We would like to firmly express our disappointment that wellbeing measures do not include housing or homelessness. Housing is a critical issue for so many Australians. The falling provision of social and affordable housing, and rental markets remaining expensive, insecure, and of poor quality for too many. Opportunities for households to secure or remain in home ownership have dropped. This has critical implications on the health and wellbeing of families, particularly children, and community wellbeing. The housing crisis has also severely impacted on productivity and workforce retention, particularly in rural and regional areas. Moreover, we quoted research in CHIA's first submission that demonstrated the link between investment in social and affordable housing and health and well-being outcomes.

We also believe that further consultation is needed before the government finalises its well-being measures. Although engaging with a well-informed sector, reasonably attuned to the

subject matter, it was nevertheless difficult to design and run the process and as importantly understand how the results will be used.

Methodology

The consultation pack for Stage Two formed the basis of our consultation with the sector.

CHIA and National Shelter held a joint sector briefing on the 15th May 2023 about the housing measures in the 2023-2024 federal budget, and then invited participants to respond to a survey on Measuring What Matters. The survey closed close of business 19th May 2023.

We first asked respondents to prioritise their top three policy themes, and then to provide further information on important issues for future wellbeing. Respondents were then asked to prioritise their top three descriptors under each policy theme. As housing and homelessness were not specifically included as draft descriptors under the policy themes, we included draft descriptors with a housing or homelessness focus. Finally, respondents were asked to provide information any indicators and existing data sources, as well as additional information they would like to see in the Measuring What Matters Statement.

The survey was available online via Google Forms. A total of 31 responses were received.

A summary of the outcomes is provided below. The full survey with responses is attached.

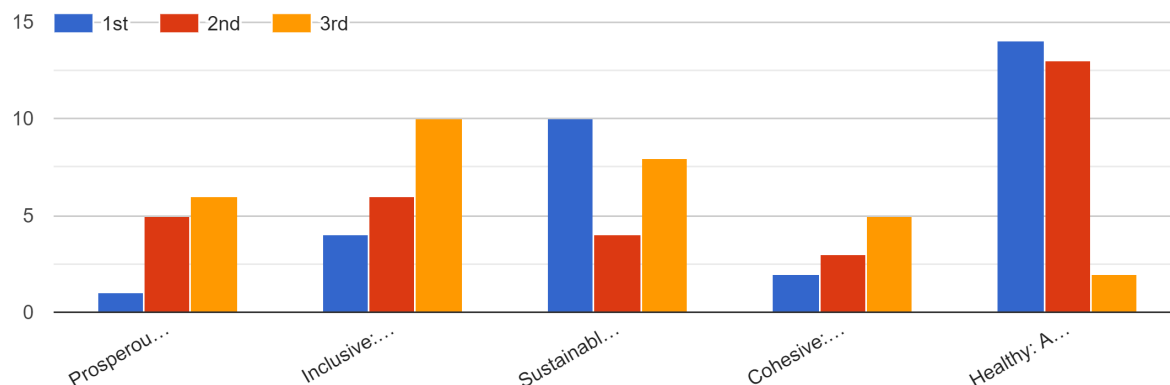

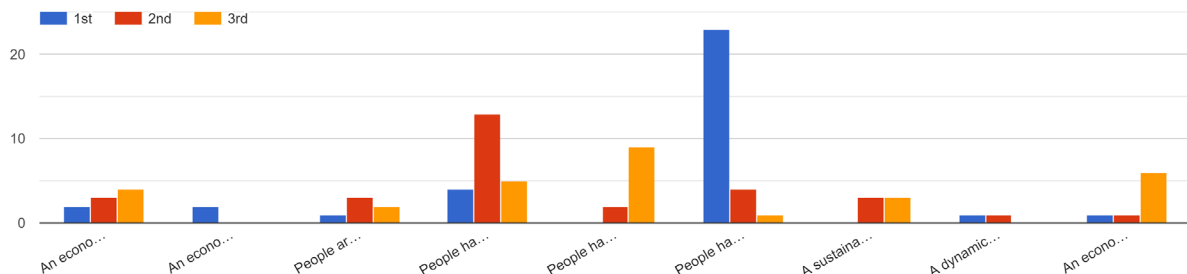
What do you see as the important issues for future wellbeing? Are these captured by the emerging policy themes?

- Wage growth as an issue affecting cost of living.
- for minimum wage workers the future is looking very grim as there just isn't enough affordable housing for key workers
- Not generating unreasonable levels of anxiety around issues that we cannot control.
- Affordability/cost of living. These issues only have Band-Aid solutions.
- Housing access & security - the emerging policy themes do not capture access to safe, affordable & secure housing as a basic human right.
- Secure and safe communities and housing. I felt this is not captured in the policy themes.
- The need to address growing wealth inequality that is particularly affecting young people. Affordable housing is a key to this.
- Addressing the social-economic inequity, which is part of the broad inclusive and economic themes but may need more specific mention or in a separate theme.
- People have access to safe, affordable and appropriate housing in the location of their choice.
- Good governance
- Mental and physical well-being, affordable housing, generational connection, Youth values, Law and order, available infrastructure.
- Affordable housing or wages to match. Access to reasonable priced and quality education. Quality of local services, public and active transport.
- Housing is obviously one of the most critical things for wellbeing & it is not adequately being addressed at the present time. Hard to believe in a prosperous country like Australia many people are struggling to put a roof over their head let alone one that contributes to their wellbeing, is well maintained to health standards & provides sufficient space for people to continue with their creative interests. Would suggest future planners & architects read the book Your Brain on Art which clearly shows how art & nature contribute to mental health.

- Future wellbeing can only be addressed when we have a system which measures itself via the social determinants of health. Policy needs true reform to address deeply embedded issues of wealth inequality, treating housing as free market commodity rather than a fundamental human right and disadvantage as a community - not individual problem. Future wellbeing can only be achieved by moving out of capitalism to a resource-based economy with social and economic settings which accept the economy is powered by PEOPLE, not abstract units of measures. Currently, emerging policy themes (or reactions) are tinkering at best and nowhere near to effectively addressing structural inequality, widening wealth gaps and exploitation of people and natural resources.
- Basic needs of all citizens are met; income inequality is addressed - difference between the lowest and highest paid needs to be low and kept low.
- Wellbeing requires that minimum expectations can be met for all people living in Australia for access to healthcare, education and a safe suitable place to live.
- Equity and equality. This is partly covered by 'Inclusive', but more focus could be placed on measuring the degree to which wellbeing is distributed amongst our community.
- So many people are in unsafe unsustainable housing and cannot afford to address other important issues including, eating properly and attending to medical matters. More affordable housing will lead to a flow on impact for many.

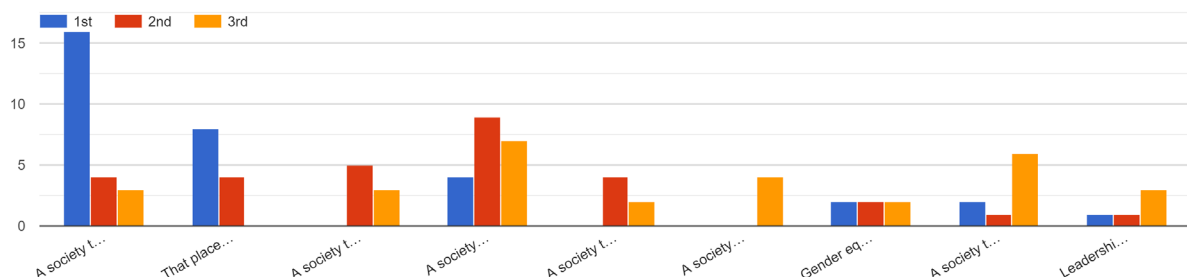
Which of the following three descriptors for the policy theme of Prosperous are most important to you?

Prosperous - a growing, productive and resilient economy Which of the following three descriptors for the policy theme of Prosperous are most important to you? (Select three)



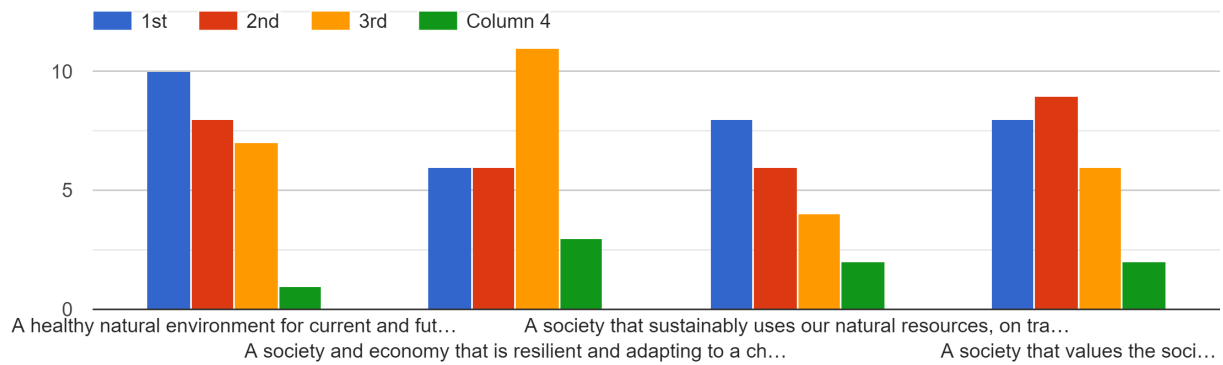
Which of the following three descriptors for the policy theme of Inclusive are most important to you?

Inclusive - a society that shares opportunities and enables people to fully participate Which of the following three descriptors for the policy theme of Inclusive are most important to you? (Select three)



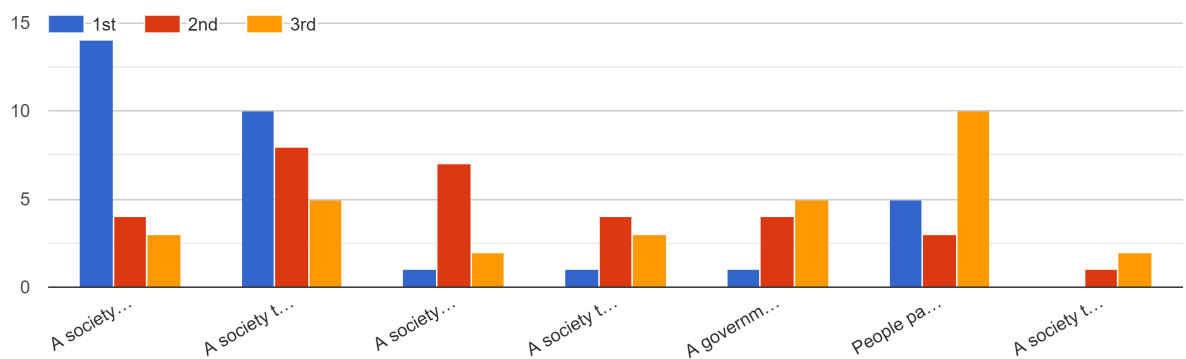
Which of the following three descriptors for the policy theme of Sustainable are most important to you?

Sustainable - a natural environment that is valued and sustainably managed in the face of a changing climate for current and future generations...ainable are most important to you? (Select three)



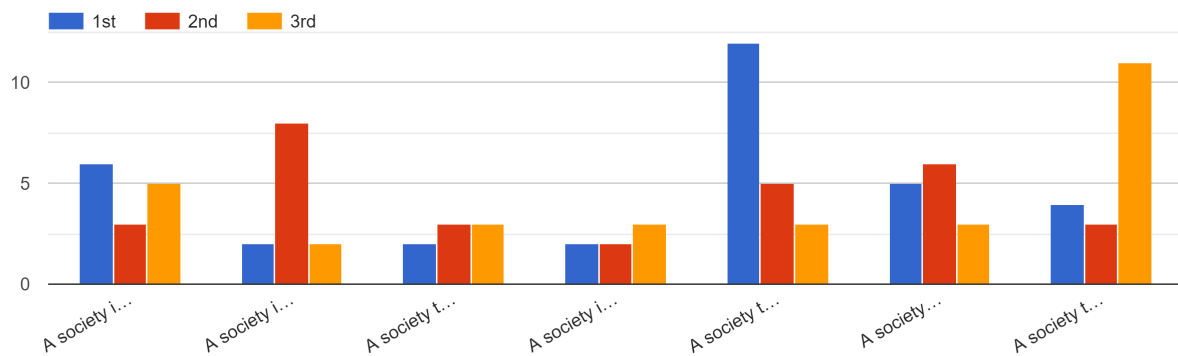

Are there any indicators and existing data sources that will be critical to inform the emerging policy themes?

- The lack of service resources to accommodate the needs of mental and physical health.
- Measures around people's access to housing (levels of housing stress, overcrowding, homelessness) and quality services (education, health, transport).
- Gender pays gap and wage inequity across industries. Annual tracking of wealth disparity in Australia. Government spending should acknowledge who financially benefits from the spending initiatives, both in the decision-making process and in post spending acquittal process. Happiness measures need to be utilised, so we consider the unique aspects that people value in their lives, these are not considered in decision-making at present. We need to measure human rights (the UN ones) and identify where people in Australia are not able to access basic human rights.
- Census, Homelessness statistics, youth incarceration statistics, Employment statistics
- There are a huge number of indicators & data sources available to those who make the decisions. What is needed is accountability & transparency so that the everyday person knows who & what are government officials are listening to.
- Australian Institute of Health and Welfare, World Health Organisation, Australian Institute as examples of data sources. Indicators such as decreasing wealth gaps, access to safe, affordable and secure housing, children's rights charter, Indigenous and Women's morality rates, women's work as a measure of GDP. Economic themes which consider a post-capitalist, post-neo liberal economy transformed to a resource-based economy.
- NCOSS Report on Mapping Economic Disadvantage
- Homelessness services data linked with other service data such as health, education, employment, justice, etc.

Is there any additional information you would like to see in the Measuring What Matters Statement? If so, please outline.

- Nil I feel that society and the current needs as it stands at the present moment speaks for itself.
- Wealth disparity, happiness and human rights. We need to measure how policy and government investment impacts wealth inequity and decisions need to be made limit support for wealthy people and improve wealth creation for those living in poverty. We need to focus less on economic measures and more on happiness and what create meaningful, healthy and happy lives, we want a government structure that focuses on the most important things. Australia needs to address our poverty problem and measure openly people's ability to access their core human rights. We need to think of human rights as a minimum standard that needs to be met.
- Measuring mental health
- All measurement should include cross-cutting themes of inclusion and equity, rather than having them as standalone themes.
- Family and domestic violence should be tackled as seriously as terrorism and the sector should be funded accordingly. Is it the 2nd largest cause of homelessness in this country and the leading cause for women and children.

Attachment Two: Survey questions

Measuring What Matters

The Australian Government is developing a new standalone Measuring What Matters Statement this year. The Statement will be Australia's first national framework on wellbeing and will evolve over time. The Statement will seek to assess progress on a broad range of social and environmental indicators alongside traditional economic measures. The October 2022-23 Budget included early ideas of Measuring What Matters.

Stage 1 of the consultation closed early this year with both [National Shelter](#) and [CHIA](#) providing submissions.
